AUGUST BANK HOLIDAY 1907



The big event in 1907 was the Dublin International Exhibition staged in Pembroke Park in Ballsbridge and is the subject of a book by Brian Siggins which will be published in the near future.

The Exhibition drew visitors from far and near and on August Bank Holiday Monday, from about Noon visitors began to arrive in Dalkey on a shuttle service of trams operated by the Dublin United Tramways Company (1896) which arrived in the town centre at less than a minute interval, were very quickly unloaded and then sent back to the city to collect more passengers. It was very fast turnaround operation and those who travelled out to Dalkey opted to go Killiney Hill or Sorrento Park with the char-a-banc operators unable to cope with the numbers who wanted to use their services and every form of vehicle was pressed into hire to bring people to and from the town from Killiney Hill which was the most popular visitor destination.

In mid afternoon there was a heavy short shower of rain which cooled the air and damped down the dust on the roads but did not cause any great exodus from the town. The Dublin South Eastern Railways also ran a shuttle train service from Dublin to Bray with Killiney Beach and Bray being the preferred destinations for these passengers as it was noticed that very few of them alighted at Dalkey.

Many of visitors to the town were from Britain who had come over to see the Exhibition and decided to include a visit Dalkey that day. There was virtually no crime reported and very few incidents of public drunkenness at a time when public intemperance in Ireland was still a matter of some concern.

Climate Consequences

I had more birds coming to my garden feeders in June than at any time during winter. Some were feeding fledglings directly from the feeders but most were adult birds feeding themselves. Probably very few insects flying about in the cool weather. Another odd consequence of the weather was that even before the bad weather struck them the terns in Kilcoole had been subject to egg predation by starlings who had bred earlier than usual during April's heatwave.

Last month I expressed concern about our tern colony on Maidens Rock off Dalkey Island. The birds hadn't nested at their usual time and we were worried that enough sand eels weren't available. Over thirty five nestboxes, a few

hundredweight of gravel and four decoy terns shipped from the US sat unused on the rock. But then there was cause for some optimism in mid June. Some Common Terns began to nest on the rock and though numbers were well down on previous years it looked like we'd at least have some birds breeding.

Unfortunately though, the treacherous weather that is becoming normal for our summers was to play its part. Later that week the weather forecast warned we were in for the worst possible conditions for the birds. Strong north easterly winds were forecast combined with a new moon which would create very high spring tides. I went down on Thursday evening and though the sea was crashing against the rock the birds were still there resolutely sitting on nests as their partners flew in to feed them sand eels. I was hopeful they might survive but next day I heard that the Little Tern colony on the beach at Kilcoole in Co. Wicklow had been washed out by the high seas with many chicks and eggs lost. Our terns in Dalkey are subject to the same conditions as the Little Tern colony in Wicklow and unfortunately so it turned out to be when I went down to look. Although I'd seen rougher seas there was a huge swell and the sea was just completely washing over the rock. No birds left and 25 nestboxes washed off as well as three of our four decoy terns. The only small compensation was since the birds had only been nesting a week it would only be eggs that would have been washed away not tern chicks. At time of writing there's no sign of any terns nesting there, the first time this has happened in the twelve years since we started our Tern Project.

Down Under up on the Hill

Bordered by Torca Road and the right of way from Torca to Knocknacree Rd the little area of parkland comprising gorse and woodland, known by some older Dalkey residents as Gorse Hill, contains some of the tallest trees in Dalkey in the shape of some of the older Eucalyptus trees that form such a noble and distinctly exotic silhouette.

Walking along the right of way on a summer evening with the sun setting and these towering trees backlit by the reddening sky you could easily imagine you could be looking at a forest in south east Asia. Equally delightful from the other side of the wood is to see the moon rising behind the trees, framed between the stark branches and the clumps of long pointed leaves. Native to Australia, eucalyptus trees do very well in Ireland's mild climate. Being the fastest growing tree and the tallest broadleaved tree, some growing to 100 metres, they are nevertheless a generally very stable tree and although some branches fall it's rare

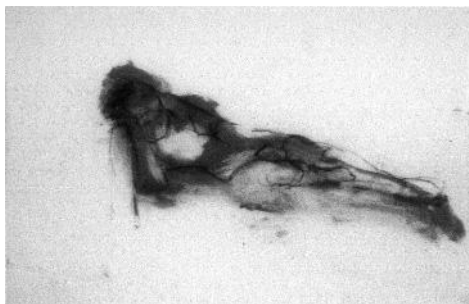

for the actual trees to be blown over. This is due to their flexibility, allowing them to bend and sway in high winds having evolved to survive in hurricanes and tropical storms . When cut the trunk of the eucalyptus doesn't have obvious growth rings since they don't have seasonal growth cycles and will keep growing when the weather is mild enough. They produce a lovely white flower often very high on the trees. When the seeds fall on to the road and get crushed by car wheels the air fills with that lovely eucalyptus oil smell. Eucalyptus is used in many products designed to unblock nasal passages. Eucalyptus is a very useful tree for birds and mammals in their native Australia but here they're more useful as a roosting tree for Hooded Crows, Jackdaws and Wood Pigeons and their height makes them a good vantage place for perching Sparrowhawks and Peregrines as well. I've seen ravens, fly into to perch in them and then virtually disappear from sight, stealthily concealing themselves from the unwanted attention they'd get from other members of the crow family.

But the Torca Road eucalyptus have been responsible for some very unlikely avian visitors over the years. Many years ago a eucalyptus was growing in our neighbours garden and looking out the kitchen window one evening I saw a large conspicuously white bird perched on it. It was a Sulphur Crested Cockatoo! Undoubtedly a escaped bird, I heard afterwards that a cockatoo which had spent many years in a cage in a school quadrant had been released in a misguided attempt to liberate it, presumably the same bird. Was it coincidence a bird native to Australia had found itself in a tree native to the same country although it had probably been born in captivity and never seen one before? Subsequently a pair of cockatiels also appeared in the wood and later two more individual cockatiels, - their very loud call sounding as shrill as a referee's whistle.

It was one lunchtime over ten years ago that possibly the most unlikely bird appeared. Walking the dog around the wood we heard a very strange call and looking around saw a silhouette of a large bird being harassed by crows and magpies. The sun was bright behind it but we could see it was big as a crow with a very heavy bill. Two chaps walking behind us had also been drawn to the noise and said they'd never seen a bird like it. It's call had stuck in my head and later that day I mentioned to an employee of Birdwatch that I'd heard what sounded like a Kookaburra, a well known member of the kingfisher family unique to Australia. The Kookaburra, like the cuckoo and chiffchaff, is named after the sound of its call and that's what the call we'd heard sounded like. When he replied that someone, who had lived in Australia, had recently rang up Birdwatch head office to report they'd seen a Kookaburra in their garden in Shankill I thought that was more then a coincidence and that was surely the bird we'd seen. Evidently something buried deep in the bird's genetic make up had brought them to this little grove of trees from their original country of origin. This bit of land was once part of a garden and at one spot under the gorse there's still the cement foundations of some kind of garden hut or gazebo. I have no great regard for griselinia hedges but there's a few plants of it in the wood, possibly the remains of a hedge which have grown to the height of a reasonably sized tree.

Having dense cover and being relatively undisturbed it's still a good habitat for native birds and beasts. Blackcaps, Chiffchaff, Goldcrest are just some of the birds that breed there, we had a cuckoo calling from the woodland one spring, and a Long-Eared Owl is occasionally seen flying through the trees. It used be a good spot for hedgehogs though they are now rarely seen as well as fox and rabbits. And in mid summer this year our suspicions about the half gnawed pine cones we'd seen on the road were proved well founded when we saw a red squirrel feeding on trees over the roadside.

THE DO'S AND DON'TS FOR SAFE PARKING *



- Do park as close as possible to the kerb or edge of the road.
- Do make sure that the sides of your vehicle are parallel to the kerb, unless a traffic sign indicates otherwise.
- Do park facing in the same direction as the traffic, if possible.
- Do make sure that your vehicle can be seen at night.
- Do park courteously, without blocking other road users' views of a traffic signal or the road ahead, or blocking the entrance to a property unless you have the owner's permission.
- Do check before opening car/truck doors for other users nearby - in particular cyclists, motorcyclists, and pedestrians.
- Don't park opposite another vehicle on a narrow road.
- Don't double park.
- Don't park at road works.
- Don't park at the entrance/exit to a fire station, Garda Station, ambulance station or hospital.
- Don't park where parking is forbidden by traffic signs or road markings.

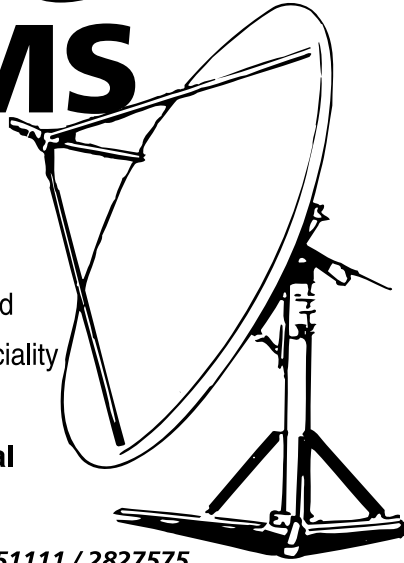

MY GARDEN by Philippa Thomas



I wonder, how's your garden doing? I do hope that all of us Dalkey folk are making time to relax and have happy and fun times in our gardens. This month of August and then, with September following quickly after, they can, as we know, be truly glorious times for hints, tints, tones and Big Bold splashes of colour.

So far, this summer I have got the most pleasure out of covering two really cheap but lovely arches. They are dark green in colour so obviously they complement our wonderful tapestry of greens. Yes, they were 'Buy One get One Free' I got both for under €15.00 which was fantastic value, don't you agree? Every now and then I take out our step ladder and weave and thread the new growth of our various climbers through. Ramblers and climbers seem to grow more vigorously when supported. We have a Campsis, I think it is Grandiflora 'Madame Gallen'. It is an evergreen species which flowers in August. Its flowers are large trumpet-shaped, pinkish & lilac in colour. This one, I think, is a particularly beautiful climber because its new growth arches down ever so elegantly and gracefully. It is a strong grower and develops quite a woody stem, even in our restricted location where we previously removed four or five bricks of cobblelock and substituted with John Innes No. 3 and some very well rotted horse manure. Now that we have it, I couldn't be without it and being so impressed with its performance, I treated us to another variety, Campsis Radicans, (Trumpet Creeper) which has stunning orange red tubular flowers and - would you believe it - only cost €4.99 in one of our large supermarket chains. Beside our Campsis, we have a blue Passion Flower (again, evergreen). It has large circular leaves so they twist and twirl through our Campsis with another little charmer, an oyster pink jasmine. I think that all look delightful and work well together

There is still time to get going and try something similarif the fad suits you? Maybe try a honeysuckle (Lonicera) one of the less invasive varieties and perhaps a rambling rose such as New Dawn (pale, shell pink roses) or 'Blush Rambler', fragrant and almost thornless. Even a wisteria or Golden Hop (Humulus Aureus) could work well. Another superb climber is Schisandra Rubriflora (a deciduous twining plant producing small buttercup-shaped, red wax-like flowers in pendulous bunches in late Spring). I bought ours in the U.K. for £12.00.

We have our Golden Hop positioned outside our kitchen door where it is very dark and damp so obviously this climber is really invaluable as it literally lights up this area. Its leaves are large and brittle and must be simply one of the most vivid shades of lime green. The truth is during our winter months, I long for its dramatic and sunny arrival and every time I look at its tender new growth, I think of tiny torches of light.

Arches and obelisks add a new dimension to the garden. They frame and provide shelter. I love to see a chair close by or to the side of an arch. It's as if it is saying: 'Please come and sit and rest - just for a while, just for a few minutes'. An arch too is a bonus for our birds, especially at nesting time. We found two birds' nests recently nestled in the very tips of our

NATURE'S CURES

Since early days the rose Rosa Sp. has been extolled for not only its beauty and perfume but also for its medicinal virtues. Of all flowers there would be very few of us who would not recognize the common garden rose. Roses have been in cultivation since the earliest times and have undergone considerable natural mutation in and out of the wild. Rosa gallica, Rosa centifolia, Rosa Damascena and Rosa alba were the most important roses used traditionally for medicine.



The rose is considered to be native to the Middle East. There seems, however, to be contradictory evidence as to its birth place. Some literature suggests Persia and that from here it spread across Asia minor to Greece and the rest of Europe. Alternatively it is suggested that the Nestorian Greeks carried Greek civilisation East to Persia, where Greek medicine was translated to Arabic.

The word rose comes from the Greek rodon meaning red as the rose of the ancients was of a deep crimson colour. This probably suggested the fable of its springing from the blood of Adonis. Again this is one theory as the rose of all flowers is probably the one most steeped in legend and symbolism.

Rosa flower preparations are shown to have a long and much valued history of medicinal use. Rose was one of the four hundred simples used by Hippocrates 'the father of medicine' and it was an official medicine in the Pharmacopoeia well into the 1930's.

Rose is anti-inflammatory, anti-microbial, astringent, analgesic and a general healer. It may be used for digestive and respiratory problems but has a particular affinity for the female reproductive system, the heart and nervous system.

Rose petals, rose hips and rose oil have a restoring and uplifting effect on the nervous system and may be used to relieve insomnia, irritation, depression, anger and grief. According to Culpeper rose 'strengthens and comforts the heart'.

Both the leaves and petals have a cooling effect and may be used to reduce fevers and to clear toxins. Through their cleansing action they also enhance immunity. Rose tea can help relieve cold and flu symptoms, sore throats and runny noses.

Rose has an interesting effect on the digestive system as it not only a useful astringent remedy for diarrhoea but may also be used as a laxative. It strengthens the stomach, aids digestion and helps relieve symptoms associated with a sluggish liver such as headaches and constipation.


Rose petals may be used to treat infertility, irregular periods and is invaluable in treating many symptoms of the menopause especially hot flushes. Rosewater sprayed on the face will bring immediate results!

Externally rosewater is used to cleanse and tone the skin, prevent wrinkles and clear skin blemishes such as acne, spots, boils and abscesses. Rosewater or an infusion may be used to bathe sore, tired and inflamed eyes.

A handy tipthe Romans apparently wore wreaths or roses on their heads as a preventative against drunkenness!

arches. I guess they love the height and feel safe from their predators. You can hang a wind chime, bird seed or whatever on your arch too.

On our second arch we have two clematis growing. Both have small, nodding, double, almost pendulous flowers. One is called ‘First Love’, a creamy-yellow, frilly double and then, a sensational ‘Marie Rose’ (one of the oldest varieties) which has black magenta nodding frills.

So obviously, my ‘Thing’ at present are arches and similar structures. Our climbers definitely flower better when suspended on an arch rather than a wall - even a sunny wall.

Long term, I think arches are easier to keep under control than vigorous growth, ‘bushing out’ on walls, especially in confined areas. Really, there’s nothing more pleasing and beautiful than nature taking its own course on an arch. The foliage/growth seems to be almost saying ‘Thank You for allowing me to scramble, twist and twirl and turn around!’

If you find the time, perhaps you might take a walk around Hyde Road & St. Begnet’s Villas. My goodness, there are some of the most interesting gardens there! People seem to make such an effort. Notice some of their successful planting, such as their choice of hedging, small ornamental trees, climbers and general bedding. Yesterday, I walked up the Flags and saw that the Scots Pine, Birch, Hazel and Blackthorns are definitely beginning to establish themselves.

Tip I – Train your new fresh growth of climbers with gardener’s green twine as wire tends to sever the soft shoots

Tip II – I acquired a very large catering-size empty plastic Ballygowan see-through bottle; 10”x 10” and filled the base with dried Sphagnum Moss (from New Zealand). This moss is harvested from renewable moss fields - generally, it’s called ‘Just Moss’. Just Moss is sterile and has high zinc content. This ensures that the roots of plants remain healthy. It also has extraordinary water retention. Spagnum Moss absorbs up to 20 times its own weight. I then cut the top off this bottle in such a way that I can replace it so as to create my own micro climate - great for sick or struggling plants. So, just before my recent short break I put a rather slow weak fern into it and on my return I noticed eight or nine fronds, slowly and assuredly unfurling. Isn’t this amazing?

LETTER TO THE EDITOR

PEDESTRIAN CROSSINGS

According to Dalkey Community Council's report in the local Newsletter for July, completion of the long-awaited pedestrian crossing for Dalkey (presumably on Castle Street) was delayed further. But what about the junction of Castle Park and Barnhill Road? It's apparent that a crossing for pedestrians is not being erected there, despite promises from councillors during the election campaign.

The new roundabout layout at the Castlepark junction includes a small island. That may provide a limited refuge for walkers who scurry across the busy road to avoid the relentless traffic. The stopgap for a proper crossing, however, is a dangerous trap for walkers. A false impression of safety could be given because drivers usually don't stop.

It's difficult to get information from Dun Laoghaire Council but my recent phone call to their offices elicited a vague response: The annual quota for erecting pedestrian crossings has been filled, and walkers should be alright on the new layout. People who use the busy junction would disagree with such a complacent attitude by officials. Since the election, councillors are reluctant to reply to queries.

Meanwhile, motorists continue to park illegally on pavements, including the widened footpath near Barnhill Stores. Do the authorities or anyone else care about walkers, including parents wheeling buggies?

TRAFFIC MATTERS (6)

MOTORCYCLISTS should realise that it is NOT a safety measure to drive around using FULL-BEAM headlights, day or night, as they blind on-coming drivers and can actually cause an accident.

YOUNG DRIVERS, in particular, should also realise that it is illegal for them to use FULL-BEAM headlights for the same reason as above.

CAR/TRUCK DRIVERS should note that if they have a tow-bar on the rear of their vehicle then that adds about 6 inches to the length of it and they should bear that in mind when reversing into a parking space. You must NOT damage the vehicle either in front or behind you as you park.

❖ GLIMPSES OF OLD DALKEY . . . *Continued from July Issue* ❖

Leaving the harbour and going Dalkey-wards on the Harbour Road we pass several fine residences, one of which bears the apparently foreign name of "Bartra", which however, on examination appears to be "bar na traigh" or, in English, "top of the shore",

On the right we pass extensive and now deserted Meagher's Quarry, which in its day teemed with activity. Above it stands the imposing Church of Ireland Parish Church. The Ballast Office of Dublin, which owned Harbour Road, (at that time called Ballast Office Road), gave the site free. The building, commenced in 1839, was opened by Archbishop Whately on 5th March, 1843. Mr. Charles Leslie, of whom you will hear further on, is remembered in the erection of the pulpit and the reading desk; he also presented a bell and an organ. The stained-glass window over the Communion Table is in memory of Peacocke, tablets on the walls commemorate Leslie, Peacocke, Hayes of 'San Elmo' - all of whom appear later in this paper. The adjoining Parochial Hall was built to the design of Edward Carson, architect, father of Sir Edward Carson, barrister and politician. Reverend Edward Leet was the first Chaplain and continued there until 1874; the roadway beside the Rectory is still called Leet's Lane.

On the extreme end of the right wall of Harbour Road stands a cottage which, formerly kept by one "Crow" Cullen, was owned by the Ballast Office; the tenant operated a gate barring passage to all persons with genuine business on Harbour Road. Others wishing to use the road only as a means of reaching Kingstown (as it then was) were turned back to Dalkey and had to go by way of Ulverton Road.

Turning to the left at "Crow" Cullen's we come to the stately pile of Loreto Abbey, built in 1842 of the inevitable and unexcelled Dalkey granite. We leave it for the moment and go down a passage to the sea at its eastern extremity. There is a venture before us which would delight the heart of any schoolboy, for just as we reach the waves at the end of the passage and further progress seems impossible, we discern on our right the entrance to a subterranean passage of some seven feet high. Going along this we find it lighted at intervals by circular gratings in the field overhead. On our left after some distance we see an old rusted iron gate, now filled up at the back, which formerly led out to a long rock known as the "Coal Quay". Continuing on, we turn to the right at a junction and soon find ourselves at a well - Our Lady's Well. Turning back to the junction we turn right this time and find ourselves at a closed-up end - the former opening to the residence named "Villagio".

Now for an explanation of these passages and the well.

Charles Leslie lived, a century ago, in "Carraig-na-Greine" (Sunshine Rock); he was a wealthy man, a wholesale chemist in Bride Street, Dublin. About 1828, in front of Carraig-na-Greine were some squatters' cabins used by fisher folk, among them a family called Cullen. Leslie then started to build there and bought out the cottages as being an eyesore; the families scattered to other cabins or to England. Years later, a Miss Cullen came back from England, found her old home gone and having learned a thing or two in the land of the Saxon, was not easily put off but boldly asserted her right to a piece of ground and access to the well. Leslie had the well diverted from the base of the big rock where it formerly was to its present position - but she again claimed her rights. Leslie then gave her a house in Leslie Avenue, built and called so by him, and admitted her right and that of her neighbours to the well. Miss Cullen became known as "Lady Cullen" because she went away poor and came back rich, and successfully fought Leslie; it was referred to as "Lady Cullen's Fight", then "Lady Cullen's Well", then "Our Lady's Well" as it is today, and, as you see, in spite of appearances, the name has no religious significance.

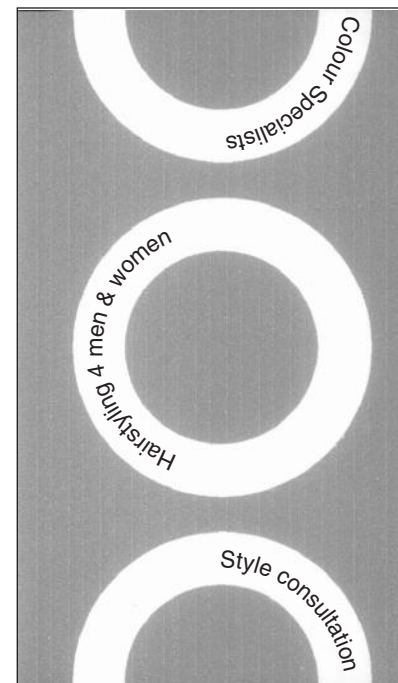
